POLICY IN RELATION TO CHILDREN LOOKED AFTER

1 Policy

- 1.1 Cardiff Children's Services believe that children are most appropriately looked after within their own families wherever this is safe and reasonable.
- 1.2 Where a parent or immediate carer of a child is unable to provide care for them, the possibility of the child being looked after by a member of their extended family or close family friends should always be fully explored.
- 1.3 A range of services will be made available to support children and young people to live at home or with extended family or friends.
- 1.4 It is recognised that for some children, the provision of accommodation by the local authority will be the most appropriate way to meet their needs. Placement will be made within a close proximity to Cardiff in order to maintain contact with friends and relatives and better co-ordinate and access support services unless the child's needs cannot be met in this way.

2 Scope

2.1 All children in need whose care plan involves the child being looked after

3 Key Principles

- 3.1 The welfare of the child is paramount, in formulating plans for their care. In most circumstances the welfare of the child is best met by being brought up within their own family. Where this is not possible and community resources are not appropriate to meet a child's identified needs, a planned period in a substitute care setting may have a positive role in providing stability.
- 3.2 Where it is not possible for children to remain with family or friends, placement away from home is designed to return them to their families as soon as possible. When return to family is not possible within realistic timescales, the policy is to place children in a permanent substitute family or care setting where they will be legally protected and can attach to a new family or to new carers.
- 3.3 LAC Services will promote the rights of children to be protected from abuse, neglect and exploitation, and safeguard the welfare of children who are looked after.

- 3.4 All services will be provided with the aim of ensuring the individual needs of the child are met. All looked after children will have access to services that are sensitive to the needs of race, culture, religion, ability, sexuality, language, ethnicity, health and education.
- 3.5 Children's Services believe that substitute care settings should provide: a flexible resource that affords children protection; offer families a chance for recovery from stress; provide opportunities for retaining family links; where appropriate enable children to return to their families; and prepare young people for to live independently.
- 3.6 All admissions to substitute care settings will be planned, based on an appropriate, assessment of need although it is accepted that admissions may sometimes be necessary either in an emergency and/or where the child is not known previously. All admissions must be made in the best interests of the child concerned; a positive choice, subject to assessment and the legislative process and requirements.
- 3.7 Plans will take account of the child's wishes, according to their age and maturity and those of their families, wherever possible, , and will be implemented according to agreed timescales
- 3.8 All admissions to substitute care settings will be to units and services that are approved by the relevant statutory agencies. The relevant regulatory body in Wales is the Care and Social Services Inspectorate for Wales (CSSIW).
- 3.9 All looked after children will be allocated an appropriately qualified worker who will be responsible for managing, co-ordinating and driving forward the child's Child Care Plan, taking into consideration the wishes and feelings of the child.
